

## **Raleigh Shag Club Meeting January 8, 2012**

1. The meeting was called to order at 6:08 p.m. by Tommy Smith, Sergeant at Arms.
2. President Margaret Griffin welcomed everyone and thanked them for the privilege of serving as the President for 2012. She asked everyone to please look around and find someone that they didn't know and go up and speak to them after the meeting. She started the meeting off with our theme "Let the Good Times Roll." She suspended the meeting temporarily and asked everyone to get up and dance to our theme.
3. The President called all board members from 2011 and 2012 to the stage. She then presented Past President, Stacy Marshall, with a plaque and thanked him for his two years of service to the Raleigh Shag Club.
4. Secretary's Report: Barb Fields noted that we did not have a meeting in December and asked the members if there were any changes to the November minutes. 7. Social Committee: Gray Pike, Kay Moore and Jayn Moore. Gray said that they are working on a lot of activities for this year – 1 or 2 bus trips, casino night, Valentine social, etc. They need help on the committee to start working on ideas for the year. 8. Membership: Debra Fearing recognized new members Jan Ellington and Brenda Lee. She stated that, as of the meeting, we have 99 members.

9. Food Coordinator: The President noted that the club does not have a Food Coordinator as yet. If anyone is interested in the job, please let her know. She thanked Terry Mears for taking care of the January meeting.
10. Ways & Means: The President noted that the club does not yet have a Ways & Means coordinator and to please let her know if you are interested. Margaret thanked Tommy Smith for handling the 50/50 raffle for the meeting.
11. Special Committees: The President said that our Sunshine Committee sends out get well cards and sympathy cards to our members. Martha Jackson and Anne Cannady took care of that in 2011 and have volunteered to continue doing it for 2012.
12. Unfinished Business:
  - a. Cabin Fever Throwdown: Earl Fowler and Tommy Smith are co chairs for the event. It will be held February 26<sup>th</sup> from 1-7 p.m. Earl Fowler could not attend today's meeting due to surgery. Tommy said that the letters are out there and members need to start looking for sponsors. He has been in touch with the NASCAR team to see if they will sponsor and/or donate items for silent auction. There will be a live auction and 50/50 raffle. He has a chairperson for the 50/50 raffle but needs a committee chairperson for the silent auction. Please contact him if you are willing to do this. John Moore will be the MC again this year and Jimmy Pearce will be the DJ. The bands are Jim Quick and the Coastline Band, The Fantastic Shakers and The Band of Oz. Angel Rissoff and Rhonda McDaniel will be there singing with some of the bands.
